## General Management Committee

### Policies, Rules, and Procedures

Created: 30 Sept. 2019

#### Policies:

- 1. The General Management Committee (GMC) will have two heads, one girl and one boy.
- 2. The title of the heads will be GMC CEOs.
- 3. The CEO position will be a nominated one. Elections will not be held and voting will not be done for this selection, or the selection of the GMC Committee members, or GMC Volunteers.
- 4. The GMC Committee members will elect two co-CEOs, one girl and one boy.
- 5. Each event will have Faculty Coordinators.
- 6. Each event will have specific Event Heads.
- 7. For an event like Shikhar, which has many components, a Chief Event Head may be designated, if one or more of the CEOs are busy with other activities. There will be no such titled position for any other event.
- 8. The GMC hierarchy will be GMC CED, GMC Chief Event Head (if designated for an event), GMC Event Heads, GMC Committee Members, and GMC Volunteers.
- 9. All Members and Volunteers of the GMC must display ethics and must be cooperative and courteous to each other, up and down the hierarchy.
- 10. Issues arising in GMC must be communicated to the Faculty Coordinators and/or the HOD of General Management (GM) in real-time.
- 11. The HOD of GM will have the final decision-making authority on policy and policy changes.

#### Rules:

- The tenure of the GMC CEO will cover the period of Sem. II and Sem. III. The CEO will be changed only if a CEO wishes to step-down, or a change is required for any unforeseeable reason.
- 2. The CEOs will be nominated in consultation with the previous GMC CEOs, GMC Event Heads, GMC Members, GMC Faculty Coordinators, by the HOD of GM.
- 3. The HOD of GM will make the final decision on the CEOs.
- 4. The GMC Members and Volunteers will be selected by the CEOs.
- 5. A Chief Event Head may be assigned for an Event in consultation with the CEOs, by the HOD of GM.
- 6. The Chief Event Head (if designated), and Event Heads will provide inputs for the Event Budget to the Faculty Coordinators and/or the HDD of GM.
- The Chief Event Head (if designated) and each Event Head will be responsible for the invoices generated against the Event Budget. The CEOs, Faculty Coordinators, and HOD of GM are the point of contact with Accounts.
- 8. The final responsibility for all issues related to invoices and the budgets rests with the HOD of GM.
- 9. A GMC Member or Volunteer can leave the GMC at will.
- 10. The final authority on the rules and rule changes related to the GMC rests with the HOD of GM.

### **Procedures:**

- The GMC CEOs will float a form for new membership for the GMC from the Junior Batch, both PGDM and MMS.
- 2. The CEOs will conduct interviews of the interested student candidates.
- 3. The CEOs will make the final selection based on the number of student candidates required, the number of events to be executed, and nature of the event activities.
- 4. The decision will be intimated to the student candidates.
- 5. The CEOs will help plan, organize, coordinate, and execute the events.
- 6. The CEOs will delegate or distribute the event components for execution to the Chief Event Head (if one is designated), and the various Event Heads, before the beginning of the event, in consultation with the Faculty Coordinators and/or the HOD of GM.
- The communication of the GMC activities must be through the GMC WhatsApp Group from the beginning to the end of the event, so that everyone is informed in real-time.
- 8. The Faculty Coordinators and/or HOD of GM will be available for consultations on any and all issues.
- 9. The Faculty Coordinators will communicate with the HOD of GM.
- 10. The HOD of GM will make all final decisions on procedures and procedure cha



### Mock Parliament – Ruling Party

Ruling Party Passes the Hawkers Bill (2019) by a Voice Vote – Opposition Walks Out Saurabh Palliwal PGDM Finance, Sem. II Div. D, 2018-20



I want to thank Masuma Ma'am and Kaul Sir first for hosting such an exciting platform and then providing me an opportunity to be a part of it. Mock Parliament is one of the most exciting events I have ever participated in as it was filled with training workshops, where Deep Sir (mentor of whole workshops and parliament) enlighten us about how a real parliament works and specially how it is different from the one shown on TV with lots of fights and highlights and an actual parliament setup. The event was hosted in front of Faculties and students of N. L. Dalmia Institute of Management Studies and Research and managed to gather healthy amount of appreciation by whole management team of our college making it a successful one. As a student it was an amazino experience to become part of such an event and this opportunity was floated to 28 students like me. As easy the event looks on stage, contrary to that are the stories and learning we get from it. We enjoyed the day we started with workshops and was happy post event with the learnings and extra ordinary experience we gained at the end.

Practice of mock parliament started with the Workshops post our regular lecture schedule, where we were supposed to understand the decorum of an actual parliament and the most difficult part was delivering everything in HINDI, and trust me this made the whole setup of parliament not only exciting but also humorous for the audience. In the first workshop

we were divided into two teams by ruling party and opposition party so as to execute a scenario of an actual parliament. And I ended up being in opposition party but then came the twist by **Deep Sir** and Masuma Ma'am as they introduced the draft in the picture where one participant from each team can be drafted to another team by request. And this became my turning point as I was drafted into the ruling party by the request of the team members of the ruling party.

Second workshop started with the distribution of roles to each member of parliament, same as actual parliament like Prime Minister, Home Minister, HRD minister, etc. I was tagged as Minister of Public welfare and in this role Shubendra Singh and I, we had to present a Bill to the Secretary of the Parliament for "Legalization of Hawkers".

Third and Forth workshops which was our last two workshops before the mock parliament were very exciting for both the parties as we not only needed to prepare for the roles assigned to us but also for the debate in Hindi. It was the responsibility of opposition party to bring out few pain-points and drawbacks of current ruling party and we needed to answer the allegations presented by the opposition party and this debate was the most exciting and entertaining part of the whole parliament. As a responsibility assigned to me, I need to present the new bill named as

"Legalization of Hawkers" and it was very much natural that opposing party was going to oppose that and hence we were instructed by the mentor that we need to be very cautious and picky while choosing rights of hawker and imposing regulations because there were lots of eyes on us from opposition party to reject this bill.

The most exciting task triggered when we started our work on preparing the bill as its not only just a draft copy but we need to do the research on what is the current situation of hawkers and is there any bill proposed earlier, if proposed what happened to that bill, i.e., if rejected why or if accepted then what is the need for the current bill. We were given two days to do the research on the topic and collate data, as much possible, and we almost completed the task on time like how we complete our MBA presentations and assignments always on time. The challenge came when we presented the bill in the Mock Lok Sabha (ruling party + opposition) and the unexpected happened rather than opposing our bill, opposing party was quiet and the bill oot rejected by the mentor stating lack of facts supporting the claim of ruling party for presenting the bill. We were not only shocked but there was a huge task in front of us to draft and prepare a whole new bill with proper claims and also needed to send it to all the members of parliament (rulino & opposing party) at least 12 hrs before the parliament session to give time to prepare opposing comments and review the bill. We in order to rise to the situation started our study post the last workshop that ended a day before mock parliament around 9 PM in the night, satisfying the engineering soul in side us. With the quote something is better than nothing and started searching for facts and figures to strengthen our claim and ended up changing all the claims we made as we were not only running out of time but also realised that the bill made earlier not only lacked claims but also the regulations. Well after study of the few earlier attempts by the government, we compiled the regulations for the hawkers' bill, and we completed our bill at around 3 AM in the morning and sent it to

the entire mock parliament group for preparation, and satisfied the MBA soul inside us for time management.

Here comes the D-day, the day of the event where we all were excited as well as nervous (about presenting everything in Hindi) for the event. The event was chaired by Ex. Mayor Mira-Bhayander Smt. Geeta **Jain** and she also played the role of Speaker in the mock parliament. The parliament started with the oath and then proceeded with discussions. Opposition came up with number of points and allegation against the ruling party and asked us to respond which turned into debate of putting their point forward where we understand the biggest lesson about parliament that along with facts and figures in place you also need good debating and commanding skills to prove your point. The discussion aka debate went on till one and half hour and we came to the last topic of the parliament session where we needed to present the bill in front of the parliament that was the first time I realised that speaking everything in Hindi is actually a very difficult task and the debate on the bill started, opposition came up with many drawback of the bill but thanks to the study we did the night before parliament. we came up with all the facts and regulations top tacked each and every allegations of opposing party, ended up in walkout of opposition from the parliament. The bill was approved by the parliament with majority of votes and passed by the speaker of the parliament. All of us with our first experience of parliament ended the Mock Parliament with our national anthem.

Mock parliament was not only an opportunity for all of us to have a feel of parliament but also filled with learnings and once a life time experience for us. Personally, I have learned many new regulations presented and attempts of government for preserving the rights of hawkers. We went through many regulations to support our claims and studied about parliament as well as the notes to debate with the opposing parties. As participants, we all are thankful of Masuma Ma'am, Kaul Sir, and Deep Sir for organising such and amazing event which ended up with lots of learning and experience.

event. Once, the bifurcation between Ruling Party & Opposition Party was done, every side had a task in hand – To rule (By presenting bills, by answering questions, etc.) and to oppose (By debating on the bills presented, by asking questions, etc.).

I was grateful enough to be elected as LOP (Leader-of-Opposition) by consensus. Now, we had our areas to discuss and work upon. Areas like, who will call attention motion (bringing some important point/issue to ponder upon), who will oppose bills with what data, who will ask questions in Question Hour and towards which minister those questions would be directed at, etc.) We worked as a team, though we were called as 'Opposition Party', we had zero opposition with repard to our way of functioning as a team. I also had an opportunity to ask questions related to Railways, to the Rail Minister. Though everyone participating, were our friends, we took it very seriously when it came to the question of acting like true lawmakers. So, when the bill named "Legalization of Hawkers" was tabled, we opposed it with all our might. backed by data including facts and figures, because we had done our homework. The event was a great learning and bonding experience, as it taught us that being in the shoes of an MP, is not an easy task, it comes with greater responsibilities. Our speaker for the event, Mrs. Geeta Jain, ex-Mayor of Mira-Bhayander, 2015-17, did a great job of managing the whole house of the Mock Parliament, as the Speaker of the Mock Lok Sabha, and I am quite grateful to everyone who helped me get this opportunity of a lifetime, which shall be forever etched in my memory. 





























## Leadership Forum Talk

The first time when Masuma Ma'am told us about the Moot Court competition we all had the same confused faces as to why would we be doing this as part of an MBA course. But the learning and the experience in itself of arguing in front of a panel is something I will always cherish.

I vividly remember reading the case given to us the first time and immediately reaching to a conclusion that the defendant would win outright and there wouldn't really be any argument or discussion. But as we dug deeper into the case and started to read more on aspects of business law particularly related to the **Memorandum** of Understanding and Articles of Association, did we realize that there was a lot more to this case than that would appear on the surface. An important part of any case is the citations one has, which are similar cases where the judge or panel had given the verdict in favour of the point you are trying to put forth. I remember sitting down with my team which included Apoorva Bellapu, Avnish Yadav, Ankita Jaiswal, Pooja Dabhade and Komal Modani, and trying to go through past cases and not being able to comprehend anything as this was the first time any of us were doing it ever. However, we did figure quickly that similar to any academic research, we didn't need to go through a lot of cases trying to find the right ones, but just needed to find the most recent appropriate one which would then in its citations contain similar cases.

The day of the competition arrived and we were finally all set to present our arguments in front of the panel. The entire setup of there being a mic in the center of the room where each lawyer would come up and present their arguments in front of the panel created a very realistic atmosphere of a courtroom. I remember feeling shaky in front of the bench which consisted some of the too lawvers in the city. I really enjoyed how we had to structure everything like it was an actual court room, and the small things like referring to the panel as "Your Lordships" and the opposition counsel as "Our friends" which is the language used in a court room, again gave us a very realistic feel. The points put forward by my team were more logical and were backed by ample citations. I even remember being able to use a citation I had read previously to counter argue the point put forward by the opposition. And finally, we were declared the winning team which made all of us feel ecstatic that all our efforts paid off.

I realize that if you are reading this you are probably still thinking how does it help somebody pursuing MBA. What we need to realize is that sooner or later there will come a time when we would have to go to the court of law maybe to represent the company you work for or maybe for something personal and this small experience that we had would better equip us to deal with such sort of circumstance if it ever arises

### Moot Court - An Incredible Ride!

Moot Courts are the closest experience a student can get of how a courtroom functions in real life. In this, a proper court scenario is created where the students act like the councillors (Advocates) presenting each side (Plaintiff and Defendant) on the basis of evidences and substantive questions of law, argue with each other to prove their point in front of the judge who in the end will give his judgment with regards to the same, and will also declare the winner who has performed the best.

We were lucky enough to have this event at N. L. Dalmia Institute of Management Studies and Research, which the GMC (General Management Committee) had conducted. It was organized on 17th March, 2019 at N. L. Dalmia's campus auditorium. It was a 2-day event where, in the preliminary round on March 16th. we were distributed among groups of 5 each and the competition was held within intra-divisions and interdivisions. We were given the 'Facts of the case' which were some handpicked case studies and we had to play our respective roles for and against it in front of the two judges each, in two separate courtrooms set up in classrooms. The external judges invited were Advocate Ahetesham Thaver, Advocate Vikram Kamath and Advocate Harsh Buch, Prof. Masuma Cyclewala also acted as on of the judges in the preliminary round.

These cases were given to us by **Prof. Masuma Ma'am**. She made sure we were shown videos of the moot courts conducted and also explained us the

entire process of how actually the courts work and made us aware of the code of conduct which was required in order to present a case. One such code of conduct was that you should never show your back to the judges. All these learnings by Ma'am allowed us to get our academic learnings closer to the practical world. It also gave us an insight as to actually how well researched the advocates should be in real life too. We also had the constant support of our HOD of General Management, Kaul Sir. He made sure everything was going as planned and everyone was enjoying as well as learning during the entire process.

Later, after presenting our cases to the judges, they were told to grade us on various aspects like our presentation skills, understanding of cases, confidence, etc. Out of all the groups, two were shortlisted for the final round the next day. It was such a feel-good moment when our group was shortlisted, all the hard work had finally paid off and we were told to present our cases in front of the judge the next day in the auditorium where there would be an audience. The next day the final round of the event was conducted under the guidance of Advocate

Ahetesham Thaver. He gave us accurate and detailed feedback of where we could improve and also taught us many lessons which will always guide us in our future endeavours.

I am thankful to the Institute, all the professors and advocates that were involved in the process for giving us such a **once-in-a lifetime opportunity**.

It is a tribute to my mentor, **Mahatma Gandhi**, whose example is an inspiration to so many of us. -- Dalai Lama at the Nobel Acceptance Lecture (1989).

Gandhi is more relevant than ever. In the 21st century, the abundance of terrorist movements mean that the world is both tired of the cycle of violence and will refuse to listen to anyone with arms. That means any movement that takes up violence will be considered bad in the world's eyes.

There are three key elements of Gandhian philosophy:

- Satyagraha Always, fight for truth, no matter what.
- 2. Ahimsa Be nonviolent in your fight. Let your mouth and deeds do the fighting.
- 3. Sarvodaya Upliftment of everyone all classes, all castes, all religions, all regions, all sexes.

These are all very relevant in the 21st century. But peaceful protests don't work in most places, right? The problem is that there are very few leaders of moral repute and patience who could utilize the tools of the Satyagraha. This is where we need better leadership who can use Gandhian tools. Gandhi was also a super intelligent politician who knew how to move people. Most modern Gandhians don't have those abilities and are resigned to small movements. But there were a few in the recent past.

Nelson Mandela did all these three and helped build bridges between blacks and whites in South Africa. He didn't let his country go in the way of Zimbabwe. At the same time, he made sure apartheid was gone. Martin Luther King Jr did the same in the US and became an inspiration for blacks and whites alike. Unlike the leaders of the black power movement, he is also respected outside the black community and outside the US. He used the same principles of the Mahatma. Recently, East Timor won its independence mostly through peaceful means. Wangari Maathai of Kenya used some of Gandhian ideals.

Some of the other **principles of Mahatma** is also very relevant now:

- Lower carbon signature & Sustainable development Gandhian movement emphasized on simplicity and antimaterialism. Escalating costs of energy and other resources will make some of this mandatory in 21st century.
- Distributed organizations Gandhi emphasized on a highly decentralized organization that coordinate in a
  manner of trust and truth. This could be applied both in politics and economics. India's Panchayat raj is one
  such example of this principle.
- Do it yourself Gandhi made his clothes by himself. His goal was to impress upon people that no job is lowly.We can get on to this DIY culture and start building some of the stuff we use.

India's National Innovation Foundation speaks of "Gandhian Engineering" - of producing sustainable things that are simple to use and have a meaning & purpose. 'Gandhian engineering' is vital for 21st century.'

Will Gandhian ideas solve all of world's problems? No. Nothing will. Each problem needs its own customized solution. But Gandhian principles can be utilized as a core block in a different solution.

Good afternoon everyone.

We would like to begin by saying that we respect **Gandhiji** and lot and his efforts for our **country's freedom** are amazing and cannot be compared.

But we feel that his principles are not relevant in today's world.

### **Concept Note**

#### Topic: 'Ascending the Shikhar of a 5 Trillion Economy'

In June, 2019, the PM said, ".... goal to make India a \$5 trillion economy is challenging, but achievable, with the concerted efforts of the states." Three weeks later, the Finance Minister (FM) in her Budget speech on July 5 said, "From \$1.85 trillion in 2014, the economy has reached \$2.7 trillion mark. We can very well **reach \$5 trillion** in the next few years." The Budget supported this growth through infrastructure and digital economy as jump-starters, with the fiscal deficit targeted at 3.3% of GDP. The Economic Survey 2018-19 states, "To achieve the objective of becoming a \$5 trillion economy by 2024-25, India needs to sustain a real GDP growth rate of 8%." The Indian nominal GDP has doubled back to back in the two decades since 1996.

India's domestic credit to private sector or private debt to GDP ratio was 49.9 percent in 2018 according to the **World Bank**, low compared to advanced countries. The country's external debt to nominal GDP ratio was 20.5 percent in 2018, according to the RBI. The FM, during the Budget, announced that the government was looking into raising funds by issuing overseas sovereign bonds. The idea is to free the borrowing space for the private sector. **Ex-Deputy Governor of the RBI** had shown that crowding of domestic funds for the private sector is greater when foreign inflows are weak. Investments help with many things like jobs, demand, capacity, and wealth creation. According to an **ex-RBI governor**, "A small issuance will likely not be problematic. The concern is that once the door is opened, the government will be tempted to issue more ...." This may have **risk of indulgence**.

The Premier of China has set the target for economic growth between 6-6.5 percent, for fiscal 2019-20. This is in anticipation of continued trade tension between the US and China. The growth is propped by investments in

infrastructure like high-speed rail, colossal bridges, and ports. How far can credit fuel growth? Can **infrastructure development alone** deliver the targeted GDP, and how soon?

A fellow at the space and ocean studies program of a **think tank** in Mumbai, monitoring ISRO's Chandrayaan-2 lunar launch has said that scientific innovation, the invention of new technology and the development of a highly skilled labor force could help India become a \$5 trillion economy by 2024.

At an AGM, the Chairman of a large **vehicle manufacturer** said, "There is no demand and no private investment, so where will growth come from? It doesn't fall from heavens. The auto industry is going through a very difficult period. Cars, commercial vehicles and two-wheelers are going through a rough patch."

According to the World Bank, the per capita GDP of India was \$2015.60 in 2018, while China's is almost 5 times and the US's over 31 times. Addressing a leadership summit in July at a college in Mumbai, a **top industrialist** of a family run business said, "It's not all a rosy picture now. One must not lose sight of the massive impoverishment plaguing our nation which can seriously damage the pace of growth going forward and prevent us from realising our potential."

The Cabinet Secretary in the ministry called for a meeting, Monday after the Budget, to discuss the vision, policy intervention, investment, and departmental responsibilities in the direction of accomplishing the 5 trillion target.

The research of the student applicants to, **Shikhar**, **the National Business School competition at NLDalmia**, must be insightful and imaginative and cover issues mentioned above and include the **following concerns** as well:

- What are the real growth drivers for a 5 trillion Indian economy?
- How is this going to shape up and will India be the next breakthrough country?
- Is this tryst wishful but pragmatic in the timeframe prescribed?
- What is the supportive data and evidence, or is it just arithmetic?
- Is there a Tao for this growth?
- What are the windows of opportunities and what are the challenges for inclusive socio-economic growth?

# Concept Note

Theme: 'Contemporary Issues in Management and Technology Interface'

Date: Tue., 7 Jan. 2020, 10:00 AM to 1:10 PM

Venue: NLDalmia Auditorium

Opportunities presented by rapidly changing technology require an ongoing evaluation of current management practices. This requires managers to examine how they think, their strategies, tactics and practices. The challenge is exasperated by the complexity of the technology and economic environment as expressed by **VUCA** and experienced by the managers. The larger corporation may have an advantage of resources while the smaller organization may have the ability not only to perceive the change, but also the ability to respond to it in real-time by virtue of being thin, lean and agile. The pace of **technology change** is such that without having to wait for accrued benefits post the payback period, a new technology implementation is to be forecasted and accomplished.

Not only is the technology changing swiftly, it is also shifting dramatically. The possibilities for management to assimilate this change in order to make decisions and the organization to absorb it lies at the cusp of the **management and technology interface** that everyone needs to deal with. Technology is also driving globalization of finance, work flows, business competitiveness, supply chain, discovery, and innovation to unpredictable outcomes and possibilities. The value proposition to the customer is continuously being challenged through digital and loT technologies. In some businesses, entry barriers are beginning to look fragile.

In today's scenario, as economies are being severely stressed, apprehensions of domestic and global investors with subdued response tend to continue in the face of ambivalent policy decisions. The **positive** wave of productivity enhancement and the **negative** fallout of job shrinkages are again at the interface of management and technology that require simultaneous and **synchronized** attention, especially in emerging economies. It also sets up a dilemma of where and how to get the knowledge workers in such a dynamic. Analysing the workforce environment today reveals that the current managers, Gen X, are tagged to their office environment; the new hires that they are bringing onboard in their organizations, Gen Y, are able to effectively combine the workplace with the home space, while the recruits of the future, the Gen Z, will have the competence and the skills to **work from anywhere**, and from any location around the globe.

As the field of Al, machine learning, Industry 4.0 automation, cloud services, and big data analytics grows, its impact is felt by increasing number of organizations around the globe. Due to unique new perspectives arising from this, managers and corporate leaders are hard pressed to **address** these issues and implications.

# Writeup on Keynote Speaker - Dr. Robert H. Ducoffe

Mentioned below are the excerpts of the keynote speaker, **Dr. Robert Ducoffe** of the event **– International Conclave** the theme of which was **"Contemporary issues in Management and Technology Interface"**.

Dr. Ducoffe began his speech by addressing the fact that, just until a few years back, colleges and could anticipate classes of high school graduates each bigger than the previous year but those days were behind us.

According to Dr. Ducoffe 25%-50% of colleges will either close or end up merging with one another. He believes that the heart of the problem is that "many colleges and universities are increasingly unable to bring in enough revenue to cover their costs."

He says up to 500 private colleges and universities offering 4-year degrees will close by 2040. The cost to attend a university increased nearly eight times faster than wages did in the U.S. between 1989 and 2016, says Dr. Ducoffe.

"The Business models of many traditional schools make them structurally incapable of responding to changes in the market that they serve. Students are inevitably beginning to question the return on their higher education investments because the costs of a college degree continue to rise and the gulf continues to widen between degree holders and the jobs available today."

Dr. Ducoffe feels that the current system of higher education fits a former industrial economy needing about 20 percent college graduates that are educated young people for their first 18 – 25 years. "Today, the global economy is rapidly **evolving knowledge** and longer lifespans are leading people to have more transitions and longer careers. Higher education needs to evolve to severe learners from before they arrive to college through after they retire."

Workers with at least some college education captured 11.5 million of the 11.6 million jobs that was created during the recovery of The Great Recession. While the jobs are back, they are not the same jobs as those lost during the recession. The Great Recession had decimated low-skill blue collar and clerical jobs, whereas the recovery added primarily high-skill managerial and professional jobs.

60% of Americans will have high-quality degrees, certificates and other credentials by 2025.

Dr. Robert Ducoffe concluded his address by apprising the students of N. L. Dalmia Institute of Management Studies and Research that, "There is a **significant challenge** to increase the performance and reduce the cost of higher education in the U.S."
