Event Summary

Finance Forum of N. L. Dalmia Institute of Management Studies and Research, Mumbai organized the **National level B-school paper presentation** competition ‘Mulyankan’, on 25th February 2023. The theme of the paper presentation for this year was ‘**Climate Finance: Evaluation, Adoption and Impact on Financial System.**’

The event began with **Master Seshan Iyer** and **Miss Priyal** welcoming all the dignitaries for the lamp-lighting ceremony, followed by the auspicious hymn of **Saraswati Vandana** to seek the blessings of Goddess Saraswati and lighting the lamp.

The first presentation was by **Team Green Goblin**, followed by QNA sessions, during which Dr. Rajkumar Adonkia posed the following query:

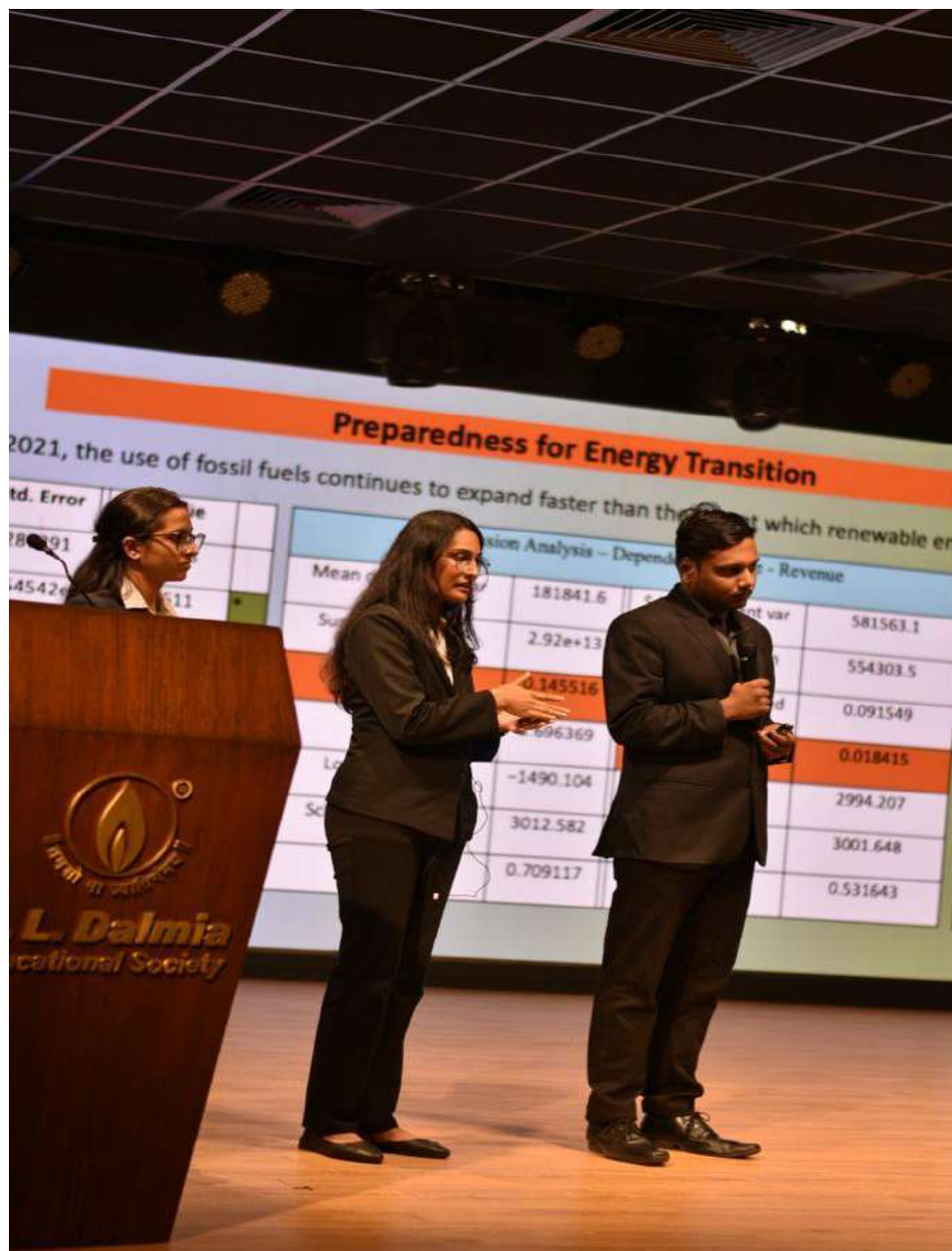
1. What is the green energy transmission project in the budget for 2023?

Team Pen Pals were second to present wherein they shared their views on “Assessing the impact of climate finance on the adoption of AR – based agriculture technology in developing countries”. It was followed up by questions asked by **CA Sneha Raole** that “In Maharashtra, we’re facing a lot of suicidal issues because of loans, why do we think that AI will be feasible for us?”



The third **Team Eco Warriors** were to present and discuss the “**Preparation for ESG, the transition in the energy sector, and the effects on the financial system**”. Meghna Mehta quizzed them on topics like "What is circular economy and what is the opposite of circular economy."



The fourth **Team FinWizards** team discussed the theme of "Green and Sustainable Finance" in their presentation." and received a few notable questions like "Difference between climate weather and seasons" and "Budget of green financing," among others.



Team Invincible was the last to speak, and Meghna Mehta then asked a question, "What is the overlap between green social and environment?" and inquiries from CA Sneha Raole, who questioned "Whether any Asian Nations had already achieved carbon neutrality.?"



All the presentations were followed where judges shared their constructive feedback and reviews. This discussion provided an immense learning opportunity for all the attendees.



Sabah Pirkhan and **Harsh Gorasia** played a quiz with the participants and attendees about climate finance as the judges were choosing the winners, and those who correctly responded received presents.
